1. Sustenance

- Your primary focus is making this entrepreneurial thing work. You aren't yet making more than you would at a JOB. In fact, you still have panic moments about money... perhaps it is a persistent state of anxiety over money. You would gladly work some extra hours/nights/weekends for this particular worry to go away. You need to get to a sustainable income ASAP! And this needs to be the guiding light behind all of your endeavors.
- At this stage, the business is very fragile. And so are you. You cannot compromise on ANYTHING! Every decision, every task, needs to align to the objective of making enough money to achieve SUSTENANCE!

2. Abundance
